## Frequently Asked Questions

- 1. Will my student turn in a paper copy for course selections
  - Students will make their course selections through their 4 year plan in Student Access. No paper copies will be submitted, but all students will receive a course selection sheet so they can see the classes offered at their grade level.
- 2. What if the 4 year plan isn't completed?
  - Counselors have worked with students each year to complete their plans. If a year isn't complete, students need
    to complete it during the open window. Students need to be sure that next year's plan is complete. These courses
    will be used to create their schedule for 2019-2020.
- 3. Can plans made now be changed in the future?
  - Each year, students will conference with their counselor to review and make changes to the 4 year plan. Also, each year during course selection time the window will reopen and adjustments can be made again.
- 4. Where can I find the electronic course selection?
  - The course selection can be found on the 4-year plan tab in Student Access.
- Where can I find course descriptions for courses listed in the plan or on their sheet?
  - The Program of Studies can be found under the Student Tab on the CISD site.

- 6. I can't find a class in the four year plan that is in the Program of Studies
  - The Program of Studies is a district wide document. Courses are designated by campus in the Program of Studies, so students can only choose classes that are offered at College Park. In addition, students can <u>only</u> choose courses that are on their respective sheets.
- 7. How do I know what level of course to choose for my student?
  - Teachers have been asked to advise for next year's level. You are able to see their advisements in the 4 year plan.
     They are located in the column to the right of the course your child will take next year. Teachers take into consideration student performance as well as knowing curriculum to come and how they think the student will do.
- 8. Can my child select advanced courses if it's not what the teacher advises?
  - Students are allowed to select differently than the teacher advises; however, before a student can be registered in
    the advanced course both the student and parent must view a video regarding advanced course selections.
    Students whose selections are above what the teacher has advised will be sent the information regarding viewing
    the video.
- 9. How many advanced courses can my child take?
  - There is not a limit to the number of advanced courses a student can select. Students and parents should think
    about 1) the work load, 2) commitments both in and out of school, and 3) the teacher's advisements. We want
    our students to do well academically, and you (as a family) know what the student is able to handle effectively
    and successfully.
- 10. When does the course selection time begin and end?
  - The 4-year plan will open January 15th for incoming 9th graders and January 28th for current CP students.
  - The 4-year plan tab will close for everyone February 10th.
- 11. What if my child is interested in taking a class during summer school?
  - If your student is taking a required course over summer school, it must be placed in the year as a choice. They
    will communicate with their counselor what course will need to replace it after successful completion of summer
    school. If it is not required, it does not need to be listed in the plan for the following year.
